DUTIES OF THE OFFICERS

(Must be current WSSA members)

OFFICE OF THE PRESIDENT-ELECT: (Three-year term consists of President-Elect, President and Past President) The President-Elect shall be the representative of the President on matters referred to him/her and shall upon request of, or in the absence of the President, preside over meetings of the Annual Conference or Executive Committee.

TREASURER (Two year term)

The Treasurer shall receive all funds collected from all sources. The Treasurer shall record all receipts and disbursements and shall make a complete financial report at the Annual Conference and such other reports as may be required by the Executive Committee. The Treasurer shall pay by check, drawn funds, bonds, and securities in a bank approved by the Executive Committee. The Treasurer shall be compensated for duties related to the assumption of the office as recommended and approved by the Executive Committee.

HISTORIAN (Two year term)

The Historian shall be responsible for compiling and maintaining the historical record of the Association and will have authority to request from the officers and committee chairpersons information necessary for the performance of the office. The Historian shall find storage space for the historical files. This shall be done with the approval of the Executive Committee.

OFFICE OF THE PRESIDENT (INFORMATION ONLY): The President shall be the Chief Executive of the Association. The duties shall be to see that the provision of the Constitution and Bylaws, the regulations and policies established there under are observed. He/she shall be the presiding officer at the Annual Conference and all other WSSA meetings.

The President shall have the authority to designate the President-Elect to act in place of the

President at public gatherings, at the Annual Conference and at Executive Committee meetings. In the event that the President-Elect cannot accept any assignment, the President may appoint another representative.

The President may make appointments to committees of other organizations with approval of the Executive Committee. Appointees may be discharged after filing a report with the Executive Committee or by action of the President. The President shall be compensated for duties related to the assumption of the office as recommended by the Finance Committee and approved by the Executive Committee.



NOMINATE SOMEONE FOR AN AWARD!

t's time to start thinking about nominating someone you know for a WSSA award! The purpose of awards is to acknowledge and recognize individuals who exhibit leadership and have demonstrated outstanding performance in their position and have made an unique contribution in the social/human services field.

The WSSA awards available include the following: Distinguished Service, Excellence in Economic Support, Excellence in Social/Human Services, the Gayl Farris Outstanding Clerical, County Board member, Membership Liaison and Rookie of the Year. In addition, WSSA members can be nominated at any time during the year for Honorary Life Membership, with awards presented at the annual conference. Individuals who have been of significant benefit to the Association but pending loss of their eligibility for regular membership due to retirement are eligible for Honorary Life.



Per an Executive Committee decision, an individual does not have to be a WSSA member to nominate someone and the person nominated does not have to be a WSSA member for the following awards: Excellence in Social/Human Services, Excellence in Economic Support, and County Board.

In addition, WSSA offers up to two scholarships of \$500 each to WSSA members who are pursuing their career and education in the social/human services field and meet the criteria. A conference grant (for a total of \$500) is also available to WSSA members who attend a State conference which is related to human/social services programs and relevant to the applicant's current job duties.

The Friend of WSSA award was established in 2000 to recognize an agency or organization that has demonstrated exceptional support for the goals and objectives of WSSA. It acknowledges contributions made by a county, agency or organization through participation, lending of its members of time or other resources to sustain the ideals of WSSA.

GOING BACK TO SCHOOL? SCHOLARSHIPS ARE AVAILABLE!



Each year, WSSA offers up to two scholarships with a total of \$1,000 (\$500 each) to WSSA member. Applicants must be a current member in good standing with WSSA and a WSSA member for at least two years. The following is the criteria:

SCHOLARSHIPS: Up to two scholarships, for a total of \$1,000 (\$500 each) are available to be awarded to WSSA members who are pursuing their career in social/human services at the undergraduate, graduate or associate degree level. The applicant must be a Wisconsin resident and employed by a social/human

services agency for at least two years. The applicant must be enrolled in a college or technical institute for a minimum of six credits. The application form must be signed by the applicant and submitted with two letters of recommendation. The winner is presented a certificate of scholarship at the annual WSSA conference and a check is sent to the scholarship recipient upon verification of enrollment in an institute of higher education.

CONFERENCE GRANTS are available to WSSA members (one or more conferences) for a total value of \$500. Criteria includes: all state and national conferences will be considered, conference content must be related to human/social services programs, the conference must benefit the individual, agency and WSSA, and conference money is to cover conference registration, hotel, meals and other travel expenses up to \$500 (minus agency contribution).

For conference grants, the applicant must be a current member in good standing with WSSA and a WSSA member for at least the past two years. Responsibilities of the recipient of a conference grant include: any additional costs or encumbrances of attending the conference beyond what are awarded by WSSA, approval by county or agency of employment to attend and participant will be required to give WSSA an overview of the conference attended and provide an article to be published in the Update.
